Circular Letter: PL 06/2024

Re: Temporary Development Contribution waiver: Uisce Éireann Water Connection Charge refund arrangements

Dear Director of Planning

As you are aware, <u>Circular Letter PL 02/2024</u> announced an extension for the waiving of local authority "section 48" development contributions in respect of residential development commenced not later than 31 December 2024 and the refunding of Uisce Éireann water and waste water connection charges in respect of residential development commenced not later than 30 September 2024.

The date for the completion of development works on qualifying units under this scheme has been extended from 31 December 2025 to 31 December 2026.

As part of this scheme, Local Authority Planning Departments provide a **Letter of Approval (LOA)** to confirm that the development has met the scheme criteria for developments commenced on site on or before the 30 September 2024.

As Uisce Éireann is not the authority with responsibility from a Building Control Regulations perspective in terms of the timeline around the 14 or 7 day notices and how that translates to an "*actual commencement date*", it is the responsibility of the relevant Local Authority Planning Department to promptly issue the Letter of Approval in line with the scheme requirements.

As we approach the end of the scheme next week, it is important to note that Letters of Approval will need to change after the 30 September 2024 to ensure they do not incorrectly support Uisce Éireann application refunds after the scheme has ended.



To summarise;

- Developments that meet the Uisce Éireann Scheme timelines, i.e. that <u>commence on or before 30th September 2024</u> – the original LOA template from PL 08/2023 should be used.
- Developments that do not meet the Uisce Éireann Scheme timelines, i.e. that <u>commence after 30th September 2024</u> – the revised LOA template included below should be used.

It should be noted that as this development has commenced after the 30 September 2024, the development will not meet the Uisce Éireann standard connection charges refund scheme timelines as set out in PL02/2024 and an application for refund cannot be made to Uisce Éireann.
